### **Notable Cases**

#### R v M (2021) - s. 18 GBH (stabbing) - Junior Alone

Young defendant acquitted after running a cut-throat defence at trial.

#### R v A (2019) - Leading counsel

Multi-million pound revenue fraud.

#### R v Q (2019) - Junior alone

International Cybercrime. Read BBC Article

#### R v B & Others (2018)- Led junior

Multi-handed conspiracy to commit GBH. Gang turf war. Acquitted after 7 week trial.

#### R v A & Others (2018) – Led Junior

Conspiracy to defraud the LAA. Perverting the course of Justice. Hung jury after 7 week trial in 2018. Re-trial scheduled in 2019.

#### R v S & Others (2018) – Junior alone

Immigration fraud.

#### R v M (2017) – Junior alone

Multi-jurisdictional stalking. The case involved a vulnerable defendant suffering with Asperger's Syndrome.

#### R v X & Others (2017) Junior alone

An extremely serious case of GBH in which the victim suffered life changing injuries and permanent disability as a result of a random assault. The defendant was a young man suffering with severe learning disabilities.

#### R v A & Others (2017) - Junior alone

Gang-related conspiracy to possess a firearm (sawn-off shotgun) with intent to endanger life. Trial lasted 3 months.



Defendant accused of being party .to an agreement to commit a revenge shooting following a murder the previous day.

#### R v H & Others (2017) Junior alone

Conspiracy to possess firearms with intent to endanger life. The defendant was alleged to have supplied a firearm and ammunition to others intent on carrying out a revenge shooting. Acquitted after 6 week trial.

#### R v W & Others (2017)

The defendant was accused of biting off the ear of male during an altercation between two groups in Maidstone. Link: The Sun

# **Examples of recently reported cases - Crime**

#### R v Ahmed, Imtiaz, Imtiaz [2018] EWCA Crim 1805

Sentence disparity. Money laundering.

#### R v AB, CD, EF [2017] EWCA Crim 534

A local authority had no power, either under the Local Government Act 1972 s.222 or otherwise, to bring a prosecution in respect of a fraud on the Legal Aid Agency allegedly perpetrated by a solicitors' practice based outside the local authority's area. It was not in the public interest for a local authority to offer a national prosecutions unit as an alternative to the Crown Prosecution Service.

Application for a writ of habeas corpus ad subjiciendum and parallel judicial review regarding a decision of a District Judge who refused to discharge under s.4 of the Extradition Act 2003.
