## Career Overview

Lyall's career has been notable for its variety, albeit with a constant focus on jury advocacy and criminal law. Having obtained a degree in Scots Law, Lyall completed a conversion course and qualified at the English Bar. After pupillage, he successfully built up a self-employed practice over 14 years.

An opportunity presented itself to join the CPS as a senior crown advocate and work with the police on some of the most high profile and serious prosecutions in London (including the largest case to come out of the 2011 London Riots involving 23 defendants). Then, in 2015, Lyall joined the barristers' team in a nationwide firm of criminal defence lawyers. This led to him defending in long multi-handed conspiracy trials, including as leading counsel in a 5 month, 11-handed child sexual exploitation trial. As well as vast experience in court therefore, Lyall also has a fairly unique insight into the workings and practices of both the prosecution authorities and defence solicitors.



Throughout his years of practice, Lyall has been keen to take on jury trials and appellate advocacy at all levels. Although he has extensive experience in multi-handed cases, and has frequently led other advocates in such cases, he also achieves much satisfaction in acting for defendants in shorter trials. Lyall never forgets that every case is the most important one taking place in the country for that defendant, and always keeps client satisfaction at the forefront of his priorities.

Above all, Lyall loves persuading juries that the most unlikely stories may have a grain of truth in them.
