### **Career Overview**

Whilst being a specialist criminal and regulatory advocate, Samuel has a broad range of experience at the Bar, having regularly appeared in criminal, civil and family proceedings. Samuel has extensive experience in the preparation and presentation of cases in the Magistrates' and Crown Courts as well as those before the Family Court, County Court and Companies Court. Samuel's breadth of experience enables him to fully appreciate the criminal, civil and family jurisdictions, better enabling him to advise on the inter-relationship of parallel proceedings.

Immediately prior to joining Farringdon Chambers, Samuel spent ten months in-house at Corker Binning, advising on a range of SFO, FCA and CMA investigations and prosecutions; many of which have attracted national press attention. Samuel's knowledge and experience of white collar offences is consequently far greater than his call date would suggest.

Samuel has been commended by those instructing him for providing sound legal advice and representation in difficult circumstances. Instructing solicitors have commented upon Samuel's ability to represent vulnerable clients, particularly those suffering from mental illness.

## **Area of Practice**

Samuel has a strong criminal practice and defends and prosecutes in both the Crown and Magistrates' Courts. Samuel regularly appears in matters relating to drugs, violence, dishonesty, road traffic and sexual offences.

## **Notable Cases**

#### R v LE (Inner London Crown Court) - Fraud

Successfully mitigated in relation to five counts of fraud by abuse of position, with a total value of £75,600; receiving a sentence of 12 months' imprisonment suspended for two years, reduced from a starting point of three and a half years' custody. Complex submissions were made in relation to Section 73 of the Serious Organised Crime and Police Act 2005, this being one of only 14 such agreements entered into by the CPS that year.

#### R v P (Bournemouth Crown Court) - ABH



Secured a suspended custodial sentence for a serious section 47 ABH that occurred in the carpark of a fast food restaurant. The victim was unknown to the defendant and suffered severe psychological harm as a result of the assault. Mitigation was advanced on the basis of the defendant having been mistakenly provoked.

#### R v HK (Aylesbury Crown Court) - Dangerous Driving

Successfully mitigated following a guilty plea to one count of dangerous driving, aggravated by a police chase, severe impairment and intoxication. Obtained a sentence of 18 weeks, suspended for two years.

#### R v B (Blackfriars Crown Court)

Secured a six month suspended sentence for two section 111A Social Security Act offences arising out of a dishonest failure to disclose ownership of a property outside of England and Wales.

#### R v S (Stratford Magistrates' Court) - Assault

Secured an acquittal in relation to a violent assault on the basis of insanity after lengthy cross examination and complex legal submissions. The Defendant had a diagnosis of nocturnal epilepsy, and at the time of the assault was in post-ictal state following an earlier seizure.

#### R v G (Stevenage Magistrates' Court) - Assault

Successfully defended a violent assault against three complainants on the basis of self-defence in light of five prosecution witnesses. The outcome was achieved by highlighting clear contamination of evidence identified by the wording used by all witnesses in evidence as well as other inconsistencies established by the crown's own photographic evidence.

#### R v W (Camberwell Magistrates' Court)

Successfully resisted a Crown application to adduce hearsay evidence on the basis of it being sole and decisive, out of time and the failure of the Crown to satisfy the conditions set out in Section 116(2)(b) CJA 2003. The Crown was forced to offer no evidence.
